- 2. The Defendant, Mr Ben Jenkins, WILL NOT whether by himself or by instructing, encouraging or permitting any person to:
 - a. Contact the Claimant or any of the Claimant's employees, agents and/or contractors directly. For the avoidance of doubt, contact includes but is not limited to:
 - i. Using the work or personal email address of the Claimant or Claimant's employees, contractors and/or agents;
 - ii. Using, telephoning or messaging the Claimant or the Claimant's employees, contractors and/or agents on their work or personal mobile telephones; and
 - iii. Using social media to contact the Claimant or any of the Claimant's employees, contractors and/or agents. Using social media includes but is not limited to direct messaging. For the avoidance of doubt, social media includes 'LinkedIn'.
 - b. Tag the Claimant's employees, contractors and/or agents on social media (including personal social media). For the avoidance of doubt, social media includes 'LinkedIn'.
 - c. Use any hashtags, whether on social media or otherwise online, which

specifically name any of the Claimant's employees, contractors and/or agents. This includes but is not limited to Ruth Cooke and any other director of the Claimant.

d. Refer to any employee, agent or contractor of the Claimant by name within any publication online, save for those individuals named https://www.greensquareaccord.co.uk/about-us/our-team or have the word "Director" contained within their job title at the time of publication on the webpage.
